Adriyanto

An Indonesian citizen, born in Jakarta in 1955, he completed his Bachelor's degree in Accounting from the University of Indonesia in 1982. Started his career as Finance Manager for PT Bunyamin Brothers from 1980 to 1983 where he was later appointed as Finance Director from 1984 to 1990. From 1991 until 1994, he worked as a Director for the Lippo Development Group. In 1995 he was Associate Director for Lippo Group and from 1999



to 2000, he worked as Commissioner for PT Lippo Cikarang Tbk, PT Lippo Land Development Tbk and PT Lippo Karawaci Tbk. In 1999 he also held the position of Director for PT Lippo Merchants Finance until 2004. He joined the Company since June 2001 until January 2003, then he rejoined the Company in June 2003 as President Director and 2013 he was appointed as President Commissioner of the Company. Based on the Resolution of the Annual General Meeting of Shareholders dated April 23, 2014, he served as President Commissioner of the Company for the period of 2014 - 2017.





Willi Toisuta

An Indonesian citizen, born in Kupang in 1938, he received his Ph.D in Educational Planning from Macquarie University, Sydney, Australia in 1974. He is a prominent figure in Domestic and International education sector. His career began as a teacher at Sekolah Pendidikan Guru in Soe, Kupang, West Timor. From 1983 to 1993, he worked as a Rector for the Satya Wacana Christian University, Salatiga, Central Java. From 1994 to 2004, he worked as Adviser to Rector of the Pelita Harapan University (UPH) in Lippo Karawaci. From 1997 to 2003, he worked as Secretary of the University National Accredition Board of the National Education



Ministry of Indonesia. He was awarded a Doctor Honoris Causa (Dr.H.C.) degree in law in 1997 by the Kwansei Gakuin University, Nishinomya, Kobe Japan. He also served as Commissioner for PT Lippo Karawaci Tbk from 2000 to 2004. In 2012 he obtained his 2nd Doctoral degree in International Education from the University of the Sunshine Coast, Queensland, Australia and presently serves as Adjunct Professor at the University. In 2013 he was appointed Senior Advisor to the Minister of Home affairs of the Democratic Republic of Timor Leste and in 2014 as Senior Advisor to the Ministry of Education in Timor Leste in the area of Quality Assurance for Higher Education.
